Bridges Style for Various Reference Types

Bridges non-standard reference style was developed to shorten bibliography entries. This creates more room in fixed page-length papers for great ideas.

Names are listed by first initial, then last name. If there are two authors, use "and" between the names. If there are more than two authors, use the serial comma, also known as the Oxford comma, before the "and".

Please pay close attention to use of the punctuation in these examples. Punctuation is always located inside closing quotation marks.
